### **Supporting Staff in Long-Term Care Means Supporting Resident Care**

The pandemic shone a light on the long There is more good news. I am very standing deficiencies in long-term care and we learned how these deficiencies affected those living and working in these care homes. There were numerous accounts of staff shortages as well as concerns for the health and well-being of the staff working in this sector. The work that continuing care assistants (CCAs) and nursing staff take on to provide person-centred care can be rewarding but it can also be exhausting on the best of days. Results from a study we conducted with staff in 10 Nova Scotia nursing homes during the pandemic found 70% of CCAs and 56% of nursing staff reported experiencing moderate to severe levels of stress and 70% of CCAs reported high levels of emotional exhaustion. These findings about staff quality of work life are concerning given that we know the conditions of work will impact and work-life outcomes for staff. the conditions of care. In addition, quality of work life can affect recruitment and retention initiatives in a sector already facing workforce challenges.

There is good news, however. Existing research tells us that there are features -up report is to be released about the of the working environment that can help or hinder staff's quality of work life. These are things like leadership, culture, interactions, resources, etc. that are modifiable in order to improve staff outcomes. Better understanding of these contextual factors will enable the development and execution of support initiatives for staff.

pleased to be leading a team of committed and invested researchers and sector leaders from across Atlantic Canada on a study that will examine these contextual factors in more than 50 care homes across our region. Through this multi-year project, we will also get a better understanding of the experience of staff's mental health and well being - information that is currently lacking in Atlantic Canada. For staff in the 10 nursing homes in the 2021 study we will be able to assess the impacts of recent investments in the sector. The information from this study will help us to understand the quality of work life in long-term care, learn more about the association between conditions of work and conditions of care, and help to advance initiatives that better support health

We need to continue to address the deficiencies in long-term care. The 2020 Royal Society of Canada's (RSC) report Restoring trust: COVID-19 and the future of long term care in Canada, outlined many of these deficits. A follow achievements to date. As an author on both reports, I will be a panelist at the RSC G7 Research Summit on Healthy Aging being held in November. There is still a significant gap needing to be filled to ensure those working in longterm care feel valued and supported for the important work that they do. I am pleased to play a small part in this change.

# Research launched on staff quality of work life in long-term care

This Atlantic Canada research collaboration is up and running with data collection to get underway in Nova Scotia and Prince Edward Island this fall. Team members with the NS/PE Hub have begun reaching out to randomly selected care homes with the opportunity to participate in this study: "An Underrepresented, Undervalued Workforce: Understanding and Supporting Quality of Work Life in Long-term Care". Staff of participating care homes will complete a survey to understand their work environment, best

Project staff for the New Brunswick Hub and Newfoundland & Labrador Hub of the project are getting in place with recruitment to begin with homes in those provinces in the coming months.

This work is being done in collaboration with the TREC program of research based at the University of Alberta where the survey is also being administered with staff from care homes in Alberta.

With limited data in the Atlantic region on the association between working conditions in long-term care homes and the quality of work life for staff and the conditions of care for residents, selected care homes and their staff will be able to help investigators across the region understand what can be done to better support our long-term care staff. The project will also support building capacity for research on long-term care in the region.
