## About the Opportunity

The Mount's Nova Scotia Centre on Aging requires a Project Coordinator for its nationally funded research study examining how approaches to care shape the pathways of older adult home care clients, referred to as the Home Care Pathways Project (www.homecarepathways.ca). Home Care Pathways is an interdisciplinary research project being conducted in Nova Scotia and Manitoba. The goal is to understand how approaches to care shape client pathways of older adult home care clients with chronic and long-term conditions through the home care systems in the two provinces. The project's interdisciplinary team includes researchers from Nova Scotia and Manitoba and sector representatives at the provincial and national level. The project uses a mixed method approach which includes analysis of home care client data, case studies, and policy analysis. The project is in year 3 of its 4-year funding.

The Project Coordinator's responsibilities include management of a multi-site project according to operational plan and protocols. Specific responsibilities include: establish and monitor detailed timelines, project protocols and inter-university funding agreements; plans, prepares and organizes meetings (e.g., teleconferences, videoconferences, in person meetings); prepares ethics documents and funder reports; develops and oversees quality assurance processes; liaise with stream leads/coordinators and professional service vendors; develops promotional materials including content for project's webpage; assists with the preparation and implementation of knowledge translation activities –presentations, workshops, webinars, articles, briefing reports, project reports.

## About You

The successful candidate will have a Master's degree in a health or social sciences discipline, and will have a minimum of 3 years of demonstrated research project management experience in a university setting.

Specific qualifications include:

- Research project management with multi-site, large collaborative research team.
- Superior planning, organizational, and time management skills.
- High regard for quality and attention to detail.
- Strong interpersonal and communication skills.
- Demonstrated experience writing for various audiences.
  Demonstrated implementing mostings, workshops
- Planning and implementing meetings, workshops, webinars.
- Experience providing direction and support to trainees.
- Strong editing and copy-editing skills.
- Demonstrated experience in mixed method approaches required.
- Proficiency in software applications (i.e., Microsoft Office) is required.
- Experience with quantitative and qualitative data analysis an asset.
- Background in gerontology and/or familiarity with issues related to continuing care industry preferred.
