2021 - 2022 Undergraduate Entrance Bursary Program Guidelines, Information and Application

To be eligible to apply students must be:
- entering their first undergraduate program;
or
- transferring from another postsecondary institution and not yet completed a degree.

Education and graduate students are not eligible to apply.

A university education is a wise investment. We recognize the cost is difficult for many students and their families and believe no one should be denied a university education because of financial need.

Mount Saint Vincent University has developed an Undergraduate Entrance Bursary Program to assist those who may have reached a critical decision-making point as to whether or not they will have sufficient funds to get them through the academic year.

Our Undergraduate Entrance Bursary Program is intended to help students by supplementing their own financial contribution and that of their families toward their education. The program is not intended to replace these contributions; nor is it intended for students with sufficient resources to cover their year.

You **MUST** be receiving a student loan (government or private bank) in order to qualify for an Undergraduate Entrance Bursary.

TO BE ELIGIBLE FOR AN MSVU UNDERGRADUATE ENTRANCE BURSARY, YOU MUST BE ABLE TO CHECK (AND CONFIRM) ALL OF THE FOLLOWING:

- I have been accepted to MSVU for the **2021-2022** academic year and will start classes in September 2021 (students who begin courses at the Mount before the Fall 2021 term **are not eligible** for an Undergraduate Entrance Bursary).
- I will be taking a minimum 60% course load during the academic year; i.e., the equivalent of three half-units in the Fall semester and three half-units in the Winter semester.
- I have applied for a government student loan **OR** I plan to apply for a government student loan (only an option if your province is not accepting 2021-2022 applications by May 15 **OR** I have applied for a private bank student line of credit)
- I do not have an undergraduate degree.

ABORIGINAL ENTRANCE BURSARY AWARD

I wish to be considered for the Aboriginal Entrance Bursary Award. In the context of this voluntary self-identification question, an Aboriginal person in Canada, as recognized in the Constitution Act 1982, is a person who identifies as First Nations (Status/Non-status), Metis, Inuit cultural and/or ancestry background.

FIRST GENERATION TO ATTEND UNIVERSITY

Some awards give preference to students who are the **first generation of their family to attend university**. This is defined as 'highest level of education for either parent is less than a bachelor's degree (parents may have some postsecondary education).' Check this box if you are the first generation of your family to attend university and wish to be considered.

IMPORTANT NOTE!

Not all students who demonstrate financial need will be offered an Undergraduate Entrance Bursary. Priority will be given to those who demonstrate exceptional need as determined by the Bursary Sub-Committee. **Please complete the information on ALL four pages.**

Government Student Loan and Grants	\$	If you are a Nova Scotia student you MUST attach a copy of your My Path account showing your loan and grant estimates. If you are applying from another province, please provide an estimate of your government loan and grants amounts if available. If not provided, estimated amounts will be calculated for you.
Private Bank Loan (Student Line of Credit)	\$	For students who do not qualify for government sponsored loans, most private banks now provide loans to students enrolled in postsecondary education. The maximum amount will vary depending on the financial institution, monthly interest charges apply
Anticipated earnings during the summer months (July and August)	\$	You will have two months between graduating high school and beginning university. You should work during this time and save as much as possible for the school year

**Confirmation of
Need Form**



Students awarded an Undergraduate Entrance Bursary will be required to complete a **Confirmation of Need Form** and return it to the Financial Aid Office no later than **Monday, August 16, 2021**. This form will be provided to students with their Entrance Bursary offer. The bursary will be considered relinquished if the Confirmation of Need form is not received by the due date. You may be asked to provide proof of information included in your original application; i.e., amounts of student loans, summer earnings, rent payments, etc.

PLEASE NOTE: Every year, some students lose their Entrance bursaries because they do not return their Confirmation of Need Form. Please make note of the **August 16** deadline now so you don't forget!

Once these forms are received and approved, students will be awarded their bursary funds. Funds will be credited to their student account in two installments; 50% in Fall term and the remaining 50% in Winter term.

MSVU also offers two other financial need-based programs – an In-Course Bursary program and the Student Works program.
