^{*}This Flex plan has been designed to allow for swipes for 2 self-isolation periods/term (if a student must relocate to our self-isolation/quarantine space. The self-isolation plan includes 3 meals/day delivered to the door of the designated self-isolation space.

The remaining swipes can be used for any meal in the Dining Hall. In the event of changing Public Health parameters, this plan will allow for students to have food security and the ability to minimize exposure by reducing the need to leave campus frequently.

Unused swipes from the Fall term can be carried over for use in the Winter term. Flex dollars can be used in the new, kiosk store in Rosaria Dining Hall for convenience grocery items and sundries, take away ready to eat meals, take away ready to cook meals, etc.
