

TRAVEL TO CANADA AND QUARANTINE REGULATIONS

Before departure:

- 1. Take a COVID-19 molecular test (PCR test) 72 hours prior to your departure to Canada.
- 2. Reserve and pay for your 3-night federal quarantine in a government-authorized hotels.
- 3. Enter proof of pre-paid hotel reservation through <u>ArriveCAN</u> before boarding your flight. Download the
- 4. Register for your <u>COVID-19 arrival test</u>
- 5. Apply to enter Nova Scotia by completing the <u>NS Safe Check-in Form</u>.
- 6. For students living off-campus: Reserve your Nova Scotia 11-night quarantine hotel.
- 7. For students who will live on-campus: <u>Apply for MSVU on-campus residence</u>.
- 8. Book your taxi from the Halifax airport to your quarantine location.

- 9. Take a screenshot of your current course registration through the EllucianGo mobile app or on the <u>MyMount</u> website.

Note: if you are not studying within 4 weeks of your departure date to Canada, you will be denied entry into Nova Scotia.

- 10. Request for your <u>Confirmation of Enrolment Letter</u> from MSVU Registrar's Office.
- 11. Make sure that your medical exam is valid *(if applicable)*. **Note:** a medical exam is only valid for 12 months.

Information on these pages will help you complete the MSVU Quarantine Plan and will prepare you for your travel to Canada.

To participate in MSVU's Quarantine Plan, you must complete this form and submit it, along with the supporting confirmation documents to <u>international@MSVU.ca</u>

We will only sign your MSVU Quarantine Plan after receiving the following documents:

- 1. Nova Scotia hotel or MSVU residence booking confirmation.
- 2. Taxi from Halifax airport to place of quarantine booking confirmation.
- 3. Proof of course registration.
- 4. Approval confirmation to enter Nova Scotia.
- 5. Completed MSVU Quarantine Plan. Please read and fill out the following pages very carefully to avoid delays. *Please submit your completed plan 5 days before you travel to Canada.*

Once your form has been reviewed, we will sign it and return it to you to present at the port of entry as your quarantine plan.

Upon arrival in Canada:

- 1. Present all required documents.
- 2. Provide proof your negative COVID-19 molecular test (PCR test) taken within 72 hours prior to your departure to Canada.
- 3. Take a COVID-19 molecular test on arrival in Canada; collect your federal home test to be take on day 8 of your quarantine.
- 4. Stay in the government-authorized hotel while awaiting the results of the COVID-19 molecular test administered upon arrival.
- 5. Once you receive your negative results from the test administered upon arrival, proceed to Nova Scotia to complete the remainder of your 14-day quarantine in the MSVU approved hotel as agreed to in your quarantine plan.

Upon arrival in Nova Scotia:

- 1. Provide approval confirmation to enter Nova Scotia.
- 2. Take your prebooked taxi from the Halifax airport to your place of quarantine.
- 3. Stay in your room to complete the remainder of your quarantine period.
- 4. Complete your federal home test on day 8, following the instructions to send it to the federal testing agency.
- 5. Obtain your negative results from your federal home test.
- 6. Complete the remainder of your quarantine.

Note: You cannot leave quarantine until you have the results of your 8thday federal home test. If there is a delay in getting these federal results for any reason, you will be required to say in quarantine until the results are received. We recommend that you take your 8thday home test promptly on the morning of your 8thday and follow the instructions to arrange to have the test picked up immediately.
