### 1. Approval of Agenda

### 4. President's Announcements

#### 4.1. Conduct at Senate Meetings

R. Lumpkin read the statement on conduct as provided in the Senate Rules of Order.

R. Lumpkin gave an update on Government relations. She spoke briefly of the partnership for excellence and commented on the increased importance of bilateral agreements, noting that the Mount had its meeting to discuss a bilateral agreement earlier that day. She encouraged Senators to attend a meet and greet with the Board of Governors scheduled for Friday, October 25<sup>th</sup>, 2013 from 5-7PM. She then noted that the deadline for Honorary Doctorate nominations is November 1, 2013.

### 5. Question Period

R. Zuk asked if R. Lumpkin would care to comment on the scandal that arose at Saint Mary's University during orientation week.

R. Lumpkin commented briefly on the issue.

Z. Gallant noted that that MSVU Student Union has offered support to the SMU Student Union team as they move forward.

K. Blotnicky questioned if there is any interaction between Senior Administration and the Student Union when planning events such as the Mount's student orientation.

Z. Gallant responded yes, and also added a brief explanation of the student leaders' orientation training process.

N. Kayhani asked a question regarding the lack of available parking spots on campus. She wondered if specific parking dedicated to faculty could be an option.

B. Jessop commented that studies show designated parking spaces reduce the overall parking availability. He noted that several other measures, such as bus passes, bicycle parking, as well as a car pool site have been created to help lessen the parking problem.

N. Kayhani noted that designated parking spots seem to be the answer at other universities.

M. Forrest questioned why there are any designated parking spots on campus.

B. Jessop responded by saying he would investigate these issues and report back to Senate.

K. Kienapple noted that a number of adjunct faculty supervise theses and they should not need to duplicate the training requirement.

A. Cole noted that CORE certificates from other institutions will be honoured.

K. Kienapple noted that some Graduate Studies documents will need updating.
