R. Lumpkin welcomed new and re-elected members of Senate.

- 4. President's Announcements
 - 4.1. Conduct at Senate Meetings
 - R. Lumpkin read the *Conduct at Senate Meetings* statement.
 - R. Lumpkin invited all Senators to attend the Vinnie's TGIF event directly after the Senate meeting. She also noted that the Board of Governors has invited all Senators to attend the Friday evening of the fall BOG retreat on October 17, 2014, from 5-7:30 p.m; a formal invitation will be distributed. She then went on to read a letter of thanks from Peter Glenister on being named Librarian Emeritus.
 - R. Lumpkin then reported that a working group has undertaken to develop a statement of social responsibility for the University. She then went on to report on Government relations, noting that the bi-lateral agreements are currently being completed; these agreements will be circulated to the campus community once received. She then reported on the innovation grants noting that E. Church along with the Co-op office developed a proposal regarding experiential learning. She also mentioned an upcoming public consultation regarding postsecondary education hosted by the Department of Labour and Advanced Education. E. Church addressed the issue of surveys and spoke about the difference between research surveys and surveys used for quality assurance. She noted that Brenda Gagne, Research

Ethics Coordinator, has offered to be a resource in this area and that guidelines regarding this issue will be circulated.

In response to a question from B. Burns. E. Church noted that examples of relevant surveys would be those conducted by DLCE and the Library.

 - E. Church presented the Academic Calendar Dates 2015-2016 for information.
 - 6.2.2. Public Availability of Grades

Moved by E. Church, seconded by R. Green, that Senate approve retiring the policy on the Public Availability of Grades. CARRIED

6.2.3. Non-Sexist Language Guidelines

Moved by E. Church, seconded by A. Cole, that Senate approve retiring the Guidelines for Non-Sexist Language. CARRIED

6.2.4. Non-Degree Student Status

Moved by E. Church, seconded by L. Steele, that Senate approve the creation of the category of non-degree student. CARRIED

- B. Burns noted her support.
- S. Drain asked if these students would be included in enrolment statistics (unit count).
- E. Church responded yes.
- I. Blum wondered about the completion of prerequisites for upper-level courses.
- B. MacInnes confirmed that prerequisites would still have to be met.
- 6.2.5. Feedback to Students (for approval)

Moved by E. Church, seconded by P. Mombourquette, that Senate approve the motion presented: "All students, including those in labs and pass/fail courses, must receive written feedback from instructors before the deadline for withdrawing without academic penalty".

- L. Steele questioned how this would apply to full-unit courses, specifically to thesis courses.
- P. Mombourquette noted that the dates for feedback for a full unit course beginning in September (such as a thesis) would be February 1, by which time thesis students should have received some feedback on their work, though not in the form of a grade. He noted that the word "feedback" rather than "grade," was deliberate.
- E. Church spoke to the importance of early feedback for students on their course progress.

Senators discussed whether the deadline for feedback should be expressed in terms of the withdrawal date or some more neutral date.

In response to a question by J. Sawler, E. Church responded that practica and internships would not be included in this policy. J. MacLeod noted that exceptions such as Practica, Co-op and Internship should be spelled out in the motion.

E. Church accepted this friendly amendment.

- **Moved** by E. Church, seconded by P. Mombourquette that Senate approve the following academic calendar entry (as amended): "With the exception of Practica, Co-op and Internships, all students, including those in labs and pass/fail courses, must receive written feedback from instructors before the deadline for withdrawing without academic penalty". CARRIED
- 6.2.6. Policy on Accommodation of Students' Religious and Spiritual Observances **Moved** by E. Church, seconded by P. Mombourquette, that Senate approve the policy on Accommodation of Students' Religious and Spiritual Observances. CARRIED as amended.
 - E. Church presented and reviewed the proposed policy on the Accommodation of Students' Religious and Spiritual Observances.
 - M. Whalen expressed concern with language noting that he found the policy ambiguous and open to abuse.
 - P. Mombourquette addressed these concerns.
 - J. Mills raised a number of questions, as to the events which had prompted this policy, the consultation that had taken place, the generality of the policy, the implications for workload, and the timely distribution of a list of relevant dates.
 - E. Church responded, noting in particular that it is the intention to have these dates published and distributed prior to the start of classes.
 - Senators engaged in a lengthy discussion of this issue. Many Senators had concerns about the language used in the policy and the possibility of its abuse. Others raised questions of ethical concerns, referring to a recent incident at York University where a male student was excused from participating in group work with fellow female students due to religious reasons. Senators spoke about student rights and human rights. It was noted that the University has a duty to accommodate religious observances, unless undue hardship is incurred, and that the standard of "undue hardship" is set high. It was also noted that respect for religious beliefs or observances does not override human rights. In the context of spiritual observances such as fasting and dress codes, Senators were requested to bring questions and matters of interpretation to the appropriate Dean for clarification and resolution.
