# 1. Approval of Agenda

#### 4. President's Announcements

R. Lumpkin encouraged those present to submit nominations for the Senate award for University Governance.

Referring to a recently issued Campus Bulletin, R. Lumpkin also mentioned that the Sisters of Charity have signed an agreement with Southwest Properties Limited for the redevelopment of the former Motherhouse property. She noted that the Mount will be consulted in the process of the land redevelopment.

She also gave a brief update on the Memorandum of Understanding negotiations with the Provincial Government. The government is signaling another 3% cut in the government grant for the 2012-2013. Also, there is talk about an innovation fund to support shared services and voluntary partnerships among the various Universities. She went on to say that a one-year agreement may be drawn up pending a more comprehensive document. There is no agreement yet for a funding formula.

She also mentioned that Project Twenty 12 has now raised over 7 million dollars towards the 12 million goal to build the new building. The 2 million dollar lead gift to name the building has been received and there will be a formal announcement and celebration on February 9, 2012.

## 5. Question Period

M. Forrest asked if there would be an internal consultation process inviting the Mount community to bring forward ideas to Senior Administration regarding the land redevelopment.

R. Lumpkin responded that this was a good idea.

- 6. Committee Reports (Standing and Ad Hoc)
  - 6.1. Senate Executive
    - 6.1.1.Strategic Planning
      - R. Lumpkin referred to her memo regarding Senate Executive Agenda Item on Strategic Planning. She asked for Senators' input on the assessment of Destination 2012 and on Senate involvement in the development of the next strategic plan. In response to a question from S. Seager, R. Lumpkin responded that the whole community will be invited to make comments.
      - In response to a question from T. Larkin, R. Lumpkin stated that the working group will be made up of students, faculty, staff, alumnae, board members as well as administrators. These representatives would bring forward the opinions of their constituency regarding strategic planning.
      - L. Steele agreed with the idea of representation on a working group combined with a review of the documents key points, noting that this sounds like a reasonable approach.
      - S. Seager mentioned that the development of the teaching plan at Memorial University had been effective in obtaining community involvement in the planning process.
      - R. Lumpkin responded by saying she would look into this.
      - R. Farmer appreciated the preliminary discussion but indicated that it might be a good idea to devote an entire meeting or a large portion of a Senate meeting to the discussion of the new plan.
      - R. Lumpkin agreed saying a conversation could come about once a framework is in place to guide the discussion.
      - J. Sawler recommended that Senate be involved in the process as early as possible. Otherwise it may appear that the agenda is being thrust upon the Senate.
      - R. Lumpkin asked if anyone would be opposed to an extra meeting of Senate be scheduled for early next term.
      - R. Farmer suggested that the meeting take place prior to the next election of Senators.
      - M. Forrest wondered if there would be a role for the Senate / Board Liaison Committee in this process.
      - R. Lumpkin noted that she would consider this.
      - J. MacLeod cautioned Senate to respect the existing structures, and avoid undermining the work of existing committees.
      - R. Lumpkin responded by saying that the need to integrate the formalized Strategic Planning process with the on-going work of existing committees had been reiterated at the last meeting of the Destination 2012 Strategic Plan Implementation Committee.
      - P. Watts noted that she had additional information on the Memorial Teaching Plan process.
    - 6.1.2. Policy on Policies
      - R. Lumpkin asked for volunteers for an ad hoc committee to develop a policy and procedure template. She asked that those interested submit their names to the Secretary of Senate by Monday, December 5, 2011.
  - 6.2. Academic Policy and Planning
    - 6.2.1. Academic Calendar Dates 2012-2013

**Moved** by E. Church, seconded by M. Forrest that Senate approve the start date for Winter term 2013 as Monday, January 7 with all subsequent dates to be adjusted accordingly. CARRIED.

- S. Seager noted that this will not allow any relief for snow days.
- I. Pottie asked if the term's end date would also be adjusted.
- B. MacInnes responded yes and noted that all revisions to dates would be brought forward in January.
- M. Forrest noted the benefits to students travelling from a distance.
- B. Blenkarn noted the benefits for residence students being able to move in over a weekend.
- S. Drain asked for a friendly amendment to read that all subsequent dates will be adjusted accordingly.
- R. Lumpkin asked if there were any objections to the amendment no objections were voiced.

- C. Schneider voiced concerns regarding the elimination of the Modern Language requirement.
- J. Sharpe responded to the concern and noted that this option would give more Tourism Electives. He went on to say that these courses were added as a result of the external review.
- P. Mombourquette added that in addition to the external review the department had consulted educators in the field to craft a more sustainable program.
- R. Zuk asked if the courses outlined above will be required.
- J. Sharpe explained that the courses will become requirements if and when the forthcoming program proposals are accepted.

After some discussion of the course description of THMT 4444, a friendly amendment was accepted without objection to replace "A continuation of knowledge about" with "An advanced study of" and to remove the acronym LCD from the description.

In response to a question from P. Watts, K. Blotnicky confirmed that, once mandatory, THMT 2221 and 2244 would be developed as Distance courses.

- 6.3.2. Business and Tourism changes to existing programs (for approval)
  - 6.3.2.1. Certificate in Tourism and Hospitality Management: change to required courses

**Moved** by J. Sharpe, seconded by P. Mombourquette that Senate approve the change to required courses to the Certificate in Tourism and Hospitality Management. WITHDRAWN

J. Sawler also expressed concern regarding the removal of one unit of Modern languages.

- J. Sharpe noted that after discussion of this item UCC determined that this was an acceptable change.
- R. Zuk expressed concern about an erosion of the presence of Arts and Science courses in programs across campus, as exemplified by the removal of the language requirement. She also noted that a rationale for the removal of the language requirement would be useful to Senators. She queried why a program in Tourism would suggest that being introduced to another language would not be valuable.
- S. Seager and C. Schneider reiterated concern regarding the removal of the language requirement.
- P. Mombourquette noted value in the previous comments; however, he stated that the tourism degree is a unique degree, in that students must be equally versed in both Tourism and Business in order to complete the degree. He went on to say that the department consulted both students and those who work in the industry and built a program based on these responses. He noted that there is no other program that has a modern language requirement.
- I. Pottie questioned if a double major for professional programs had been considered? He noted that it appeared as though one program was cut to boost the enrollments of another program. Why not give the students the choice between a Modern Languages and a Communications course.
- P. Mombourquette responded that in light of the discussion the item should be withdrawn.
- K. Blotnicky noted that a detailed rationale had been presented to UCC and this will be brought forward when the item is presented again.
