- 4. President's Announcements 4.1. Conduct at Senate Meetings
 - 4.1 R. Lumpkin read the *Conduct at Senate Meetings* statement.
- R. Lumpkin briefly mentioned the 50 year Alumnae event she attended earlier in the day. She then spoke to recent government relations, noting that one section of the new MOU will contain a sexual assault policy and procedures document; she noted that the Mount is in compliance with the new language. She also mentioned the Innovations Team (University Presidents, several Deputy Ministers and the NSCC President) and their ongoing initiative and in the five areas of innovation (five working groups focused on entrepreneurship, research development and commercialization, technology and able learning, experiential learning and recruitment). She then mentioned the upcoming review of the Bachelor of Education Program for three Universities in the area.
- 5. Question Period
- J. Sawler wondered if there was a policy regarding media participation and when individuals should represent themselves as Mount employees.
- R. Lumpkin responded noting that classic protocol that employees, when expressing personal opinion, identify themselves only by name. It is understood that employees speaking on behalf of the University or as scholars associated with the University refer to their Mount affiliation.
- E. Church noted that faculty might contact Public Affairs for guidance prior to engaging with media.
- A. Humble added that although such media contacts promote the University, there is no guarantee that there will be no misrepresentation.

- R. Lumpkin added that she would take this item back to Public Affairs for their input and guidance.
- I. Pottie asked why the University has the procedures for Summer Terms differ from those for the Fall and Winter terms. The last academic plan approved January 2014 noted that enrolment patterns have shifted and that the timetable should be set up as for a year-round university. He asked whether such a shift in planning would include ensuring that the same policies and procedures (from, for example, the Registrar's Office, the Dean's Office, and the DLCE Office) would be in effect year round.
- E. Church noted that this is an on-going concern for CAPP, and that Dean Kienapple has been tasked to look at this issue. She encouraged I. Pottie to send examples of the difference in procedures (term to term) to the Dean's attention.
- L. Steele asked about the current location of the photographs of the winners of the Alumnae Teaching Award.
- R. Lumpkin responded that they had been taken away for reframing and she would follow up. E. Church added that the Alumnae Teaching Award had been suspended two years ago, though the question is under consideration by SCOTL with input from the Alumnae Association.
- R. Gechtman posed a question regarding security in the Library through the McCain Centre entrance, and the possible loss of books from unsecured entrances.
- T. Harrison responded that the Library is aware of the situation, and that steps are being taken to address it. She also mentioned that this is an active item on the agenda of the Senate Library Committee.
- C. Blayney commented on the traffic flow change in the Library area since the opening of the new building. She wondered if traffic flow and elevator usage in this area was being monitored. R. Lumpkin mentioned the ongoing take the stairs initiative.
- T. Harrison added that the traffic flow is being monitored in the Library; she added that space usage is also being monitored.
