M. Forrest questioned the legal status of the wellness agreement document, noting that a lease agreement cannot contain any type of discrimination.

P. Barry responded that students do sign a lease agreement, and she noted that the wellness agreement (regarding students' safety in residence) is an amendment to this lease agreement. She concurred with M. Forrest reiterating that the language used in the wellness agreement will be reviewed over the summer months.
