4. Announcements

R. Lumpkin reported on the Senate recommendation to the Board of Governors regarding Library security. This item was reviewed by the Board Chair and the Board Executive Committee and then referred to the Campus Planning Committee. She added that the Campus Planning Committee does have one more meeting scheduled for this academic year, and library security will be added to the agenda for this upcoming meeting. R. Lumpkin then reported on the successful grant proposal of \$400,000 received from the Windsor Foundation for the First-Year Student Experience pilot project. She offered thanks to E. Church, P. Barry, B. Taylor and everyone who worked on this initiative. R. Lumpkin then gave an update on recent Government relations. She spoke about the outcomes agreement proposal, noting the six sector wide outcomes that all Universities will be asked to report on: Revenues and Expenditures, Efficiencies and Financial Responsibility, Enrollment, Student Satisfaction, Education Quality and Sexual Violence Awareness and Prevention. In addition, the Mount has selected two additional institution specific outcomes: Under-represented Groups and Year Round Operations.

 - Senators engaged in a brief discussion of the enrollment and retention numbers. It was determined that additional retention detail (such as first year vs. second or third year and part-time vs. full-time) will be provided to Senate for future reports.
 - P. Barry then gave a brief report of 2016-17 enrollment numbers. It was reported that in comparison to last year at this time, more first-year students have paid their deposit, but enrollments by unit count and by student are lower. She also noted an enrollment increase of incoming students in AHN, ENGL and PSYC programs.
 - B. Taylor offered his thanks for providing this program specific data.
