

International Education Centre Renewing your Temporary Resident Visa under PGWP status

You may have to apply to renew your TRV if your will expires soon and you want to leave the country. If your passport is expiring, it is best that you renew your passport before applying for a TRV. Moreover, you must wait to have a valid PGWP before applying for your TRV. You can renew your TRV in Canada by applying online and sending your passport to Ottawa.

1. Log in to your online immigration account using GCkey or Sign-in Partner

*If you are a new user, you will need to create your account through GCKey or Sign-in Partner.

NOTE: Save your username and password. Consider taking a screenshot of all your security questions and answers to avoid getting locked out of your account. Once you are locked out of your account, you will never be able to access it ever again.



INSTRUCTIONS: You need to download the Adobe Acrobat Reader software to your computer that runs Windows or Mac OS. Do not use a Chromebook, tablet, or phone.

Under <u>Application Form(s)</u>. Click on the document "Application for Visitor Visa...". After clicking it, a new webpage will open up. The webpage will say "Please Wait...". You don't have to wait. Immediately press the download button of your web browser. Save the PDF file on your laptop. Go to the folder where you saved the file. Right click on the file and choose "Open with Adobe Acrobat" PDF Reader. Fill it out using a computer and not by hand/print.

Medical Exam

IMPORTANT: in-Canada applications only

IRCC created a <u>temporary public policy</u> for immigration medical exams (IMEs) <u>until October 5, 2029 only.</u> If you completed an IME within the past 5 years, submit a copy of your previous medical exam.

To qualify for this temporary policy, you must meet **all** of these conditions:

- You applied, or are applying, for either permanent residence or temporary residence.
- You already live in Canada.
- You completed your previous IME in the last 5 years.
- Your previous IME indicated a low risk or no risk to public health or public safety.

NOTE: You need to submit your proof of medical exam performed by an IRCC approved physician if you plan to work in the fields of education, childcare, medical and healthcare services, nursing homes, taking care of elderly and other vulnerable people, hospital, and agriculture, etc. Click on this link to <u>view the list of IRCC approved physicians by country</u> to book your appointment if necessary.

6. Pay the application fee with a credit card or visa/mastercard debit

Please make sure you see the official receipt on the screen. Otherwise you need to try again or use the different credit card.



7. Submit the application.

Once your application has been successfully transmitted, you will see a confirmation of application submission under "My Messages".

8. Wait for a response from IRCC and mail your passport within 30 days of approval

Once your application has been processed, IRCC will send you a letter under "My Messages" in your online account. Please **print the passport request letter** and mail it along with your passport

Go to a Canada Post Office and purchase two prepaid Xpresspost envelopes (1 big and 1 small) with tracking numbers.

In the bigger envelope, put in your passport, IRCC Letter Request for Passport, and the other smaller envelope you purchased. This smaller envelope will be used to return your passport with your new TRV to you.

Please mail your passport and letter to the following address and write "TRV Application" on your envelope (white area above the mailing label): Choose only one of the two addresses listed below.
