What does it mean to plagiarize?

According to *Webster's International Dictionary*, the definition of plagiarism is "to steal... and pass off as one's own the ideas, words, or artistic production of another; to use without credit the ideas, expressions, or productions of another."

Basically, plagiarism comes in three forms:

- Fraud
- Patch Writing (or Patchwork Plagiarism/Paraphrasing)
- Insufficient or Undocumented Paraphrasing



What does it mean to plagiarize? Continued...

Each paper that you turn in and every sentence in it must be written completely by you, or you must give proper credit to the other writers for their ideas and words with citations.

In addition, most teachers consider handing in papers that were written for other classes to be a form of plagiarism. New papers should be written for each assignment unless your teacher indicates otherwise.

Remember that writing teachers are experienced at picking out papers that contain plagiarism. Do not be tempted to download papers from the web or to "recycle" papers from other students.

Why shouldn't you plagiarize?

- 1. Plagiarizing is seen as stealing or lying
- 2. Plagiarizing puts your educational future at risk you can be expelled from the university

What does it mean to cite?

To cite – to write or say the ideas of a writer or speaker as a direct quotation or paraphrase

What is a "direct quote"?

A Direct Quote – something that is written exactly (word-for-word) from another author

What does paraphrase mean?

To Paraphrase – to state something written or spoken into different words but keeping the original meaning



To cite – to write or say the ideas of a writer or speaker as a direct quotation or paraphrase

How do you cite a direct quotation or paraphrase in your writing assignment?

There are several citation styles and style guides:

- 1. APA Style (American Psychological Association)
- 2. MLA (Modern Language Association)
- 3. Chicago Manual of Style
- 4. Nutrition Citation Style
- 5. American Chemical Society

Using APA:

Today's presentation will look at 2 types of APA citation:

- 1. The Reference List
- 2. In-text Citation
 - a paraphrase
 - o a direct quote

Citation, in any style, has a specific "formula" for each source. Whether is it the Reference List or in-text, a direct quote or a paraphrase, it must be followed always.

Creator, A. A. (Date). *Title of work* [media format/file type]. Retrieved from http://journal/homepage/index.html

Website:

Author, A. A. (Date). Title of document. Retrieved Date Accessed from http://web/address/home.html



The Reference List

- In APA, the list of sources at the end of the paper is called the Reference List
- The reference list must include all references cited in the text of your paper
- This title is at the top centre of the page in **bold** font
- Order of references is **alphabetical**, by the last name of the first author or, if author is not available by title
- For the author's first name use only initials: 'Smith, J.', not 'Smith, Jennifer'
- Use a "hanging indent" for the Reference List (to start a line of text further from the left margin use the 'Ctrl-Tab' keys or press the 'space bar' five times)
- Double-space between all lines of your work, including references



The Reference List

For example, a journal article from a database:

Tuck, E. (2012). Decolonization is not a metaphor. *Decolonization Indigeneity, Education & Society, 1*(1),pp.40. https://clas.osu.edu/sites/clas.osu.edu/files/

Formula:

Author, A. (Year). Name of the article. *Name of the periodical or journal,* (volume)(issue), pp pages. Give doi if available, if not give URL but only if URL is available to all readers

Author + First initial + period + parenthesis + date + parenthesis + period + Name of the article + period + Name of the Periodical + comma + (volume) in Italics + (issue) no Italics + comma + pp pages + period + doi or URL + no period

In-Text Citation – Direct Quote

- A direct quote copies an original author word-for-word
- Incorporated into your writing encased with double quotation marks " "
- Include the Author, Year, and page number where you found the quote

"International students benefit greatly from a mandatory pre-departure Academic Skills course" (Cahsen, 2021, p. 330).

OR

Cashen (2021) believes "international stduents benefit greatly from a mandatory pre-departure Academic Skills course (p.220).



In-Text Citation – Paraphrase

- Restate another's words or ideas using your own words
- Incorporate into your paragraph
- Include the Author and Date
- No quotation marks, no page number
- Paraphrase most of the time in your assignment, only 1-3 direct quotes
