FUNDING OPPORTUNITIES

Discovery Horizons Call for Proposals

Discovery Horizons grants support investigator-initiated individual and team projects that broadly integrate or transcend disciplines to advance knowledge in the natural sciences and engineering (NSE). Full applications submitted to this NSERC program will be reviewed by a tri-agency interdisciplinary peer review committee. In partnership with the Canadian Institutes of Health Research (CIHR) and the Social Sciences and Humanities Research Council (SSHRC), NSERC is piloting this interdisciplinary peer review mechanism. The shared peer review committee will assess all full applications submitted to NSERC's Discovery Horizons program, as well as relevant applications submitted to SSHRC's Insight Grants and CIHR's Project Grants programs.

In the context of this funding opportunity, the term "interdisciplinary" should be understood to fully encompass all research that connects, crosses or falls in between the traditional disciplines of the three agencies, including transdisciplinary, multidisciplinary, convergence research and other approaches at the interface. Discovery Horizons grants are expected to be valued from \$50K–\$100K per year and

will be commensurate to the size of the research team. For this pilot year, NSERC is expecting to award approximately 10–20 grants.

All relevant information for this funding opportunity are available on <u>NSERC's</u> website. All proposals for this call will be submitted through the <u>Convergence Portal</u>. Guidance and additional information regarding NSERC <u>specific eligibility criteria</u> and terms and conditions for participation are listed on their website. A list of frequently asked questions is below.

1. Can applicants who hold a Discovery Grant or are applying for a Discovery Grant in Fall 2021 submit a LOI to Discovery Horizons?

Yes, researchers holding a Discovery grant or applying for one this year are eligible to apply to Discovery Horizons.

- 2. Can co-applicants be from non-NSE disciplines (Economics, Sociology ...)

 As long as the faculty members meet all eligibility requirements they can be from any departments. However, in the Discovery Horizons proposal, they must work towards advancing knowledge in the NSE.
- 3. Is the proposed work under Discovery Horizons expected to be drastically different from the work proposed for Discovery? Is conceptual overlap allowed as long as there is no budgetary overlap?

Discovery Horizons proposals should be different from Discovery Grants (applied for or held) since the Discovery Horizons applications, due to their broad level of interdisciplinarity with the social sciences or health research are not suitable for the DG program. At the full application stage, applications must indicate that the funds requested from the Discovery Horizons program will be for expenses that are distinct from those covered by support from other sources. For funding applied for, you must indicate that there will be no duplication of funding for the same expense(s) and explain how funds will be used if all applications are successful.

4. Does the application need to have all three components: (1) social sciences and humanities, (2) natural sciences and engineering, and (3) health and wellness?

No, Discovery Horizons applications must be rooted in the NSE and integrate elements from the social sciences and humanities and/or health and wellness.

5. How does the Discovery Horizons Program and the Tri-Agency Interdisciplinary Peer Review process differ from the interdisciplinary research funded under the New Frontiers in Research Fund?

Although the New Frontiers in Research Fund (NFRF) was also created to fund interdisciplinary research in response to the Fundamental Science Review's recommendations, it is focused on high-risk, high-reward, and fast-breaking research and supports research that proposes novel interdisciplinary approaches that bring together disciplines that do not traditionally work together. Please see the New Frontiers in Research Fund website for more details. Discovery Horizons, as well the other funding opportunities reviewed by the Tri-Agency Interdisciplinary Peer Review Committee will complement NFRF by focusing instead on investigator-initiated interdisciplinary research projects that are aligned with the core

funding programs at each of the three major funding councils, including research projects that use existing interdisciplinary approaches.

6. Can I submit the same application to more than one of the funding opportunities participating in the Tri-Agency Interdisciplinary Peer Review Committee?

No, applicants may not identical or essentially identical applications to more than one funding opportunity participating in the pilot of the Tri-Agency Interdisciplinary Peer Review Committee, NSERC's Discovery Horizons, SSHRC's Insight Grants and CIHR's Project Grants. In addition, all applications must meet the eligibility requirements and guidelines of the funding opportunity to which they apply, including those related to multiple applications. As a result, it is important to consult the funding opportunity's webpage.

- 7. How do I determine which funding opportunity to apply in order to have my application reviewed by the Tri-Agency Interdisciplinary Peer Review Committee?
- Applicants should apply to the agency funding opportunity that supports the dominant research area of the proposal.
- 8. Will interdisciplinary applications that fall entirely within the research areas of one agency be considered by the Tri-Agency Interdisciplinary Peer Review Committee?

No, applications that fall entirely within the research areas of one agency should be directed towards existing committees or evaluation groups, based on the practice and criteria of each agency. For example, interdisciplinary research solely within the natural sciences and engineering, with no social science, humanities, health, and/or wellness components should be directed towards another NSERC program, such as the Discovery Grants Program.

[NEW] New Health Investigator Grant Competition

The New Health Investigator Grant supports early-career health researchers who are engaged in work that aligns with the province's health research priorities. The grant aims to provide two years of support of up to \$100,000 for researchers who are within the first five years of their academic appointment in Nova Scotia or who are new to the field of health research. Funding provided will support the establishment of independent programs of research, support and expand the research productivity necessary for obtaining long term funding from national and external agencies and expand the potential for early career investigators to make significant contributions in their field. For the 2022-23 academic year, funding for this grant is provided by the Nova Scotia Department of Health and Wellness. The priorities of this grant have been based on the recently released Action for Health, the strategic plan government has created to address challenges in the healthcare system. As a result, the list of priorities does not include biomedical areas of focus; therefore, RNS will not be inviting, or accepting, applications from biomedical researchers this year.

The deadline for Notice of Intent submissions will be **Tuesday**, **June 21 at 1:00pm ADT** with full applications (for those invited to submit) due on **Tuesday**, **September 13 at 1:00pm ADT**.

2022 Exploration stream competition of the New Frontiers in Research Fund (NFRF)

The goal of the Exploration stream is to inspire high-risk, high-reward and interdisciplinary research. Exploration grants support research that pushes boundaries into exciting new areas. Researchers are encouraged to think "outside of the box," undertake research that would defy current paradigms, and bring disciplines together in unexpected ways and from bold, innovative perspectives. With the Exploration stream, there is recognition that innovation often carries risk; proposals for high-risk research projects that have the potential to deliver game-changing

The maximum budget for the direct costs of the research project is \$100,000 per year, for up to two years.

2022-2023 Banting Postdoctoral Fellowships (Banting PDF) competition

The Banting Postdoctoral Fellowships program is designed to support world-class postdoctoral researchers. The fellowship provides \$70,000 per year for two years. The program is open to both Canadian and international researchers who have recently completed a PhD, PhD- equivalent, or health professional degree. Applications must be completed in full collaboration with the proposed host institution.

The Canada-U.S. Fulbright Program operates on the principle of reciprocal exchange and provides the opportunity for outstanding Canadian scholars to lecture and/or conduct research in the United States. Award recipients include prominent and promising scholars, as well as experienced professionals. During a Fulbright scholars can: conduct research; deliver lectures; network, promote their work; formal teaching (only if the awards allow it). [NEW] Special Response Fund for Trainees (Ukraine)

Through the Special Response Fund for Trainees (Ukraine), CIHR, NSERC, and SSHRC have supported many trainees who are directly impacted by the crisis in Ukraine. These funding agencies have established a limited-time Special Response Fund for Trainees (Ukraine), or SRFT-Ukraine, to initiate or maintain the employment or financial support—via stipend or salary—of graduate students and postdoctoral researchers who are directly impacted by the crisis in Ukraine.

Canada is recognized as a leader in building partnerships and uniting researchers and highly qualified personnel of different nationalities and cultures in the shared pursuit of scientific excellence. Recognizing how the crisis in Ukraine may affect the research landscape, this additional funding for grant holders will support trainees, defined as graduate students or postdoctoral researchers, through salaries and stipends. Support can be requested for a period of up to 12 months. The maximum allowable amounts are as follows: Master's level - up to \$20,000, Doctoral level - up to \$25,000, Postdoctoral level - up to \$45,000. Applications will be accepted using a continuous intake up to December 22, 2022.

Whales Spotted on Campus!

No not Bedford Basin baleens, but <u>phishing emails</u> crafted to exploit our desire to please our leaders, bosses, and authority figures. <u>Whaling</u> is a scam where they impersonate someone you respect (the big fish) asking you to do a task, like buy a gift card, provide your cell number, or write a cheque. Recently, faculty received emails from "department chairs" requesting their cell number. Then, the scammers sent obnoxious texts demanding gift cards. The email address was from @icloud.com not @msvu.ca, so always check the message's actual email address when getting unexpected emails from your professor, chair, dean, or supervisor. [NEW] Research Cybersecurity Courses

Industry Canada provides two free research cybersecurity courses called "Introduction to Research Security" and "Cyber Security for Researchers."
